2021 HSA Limits Announced

Starting in 2007, the Tax Relief and Health Care Act of 2006 (TRHCA) requires that the IRS release the upcoming year's new HSA limits prior to June 1st. Thus, we now have the 2021 HSA limits as follows:

Annual contribution limit - Individual	\$3,550	\$3,600
Annual contribution limit - Family	7,100	7,200
Annual catch-up contribution limit (age 55 to 65)	1,000	1,000
Minimum deductible for HDHP - Individual	1,400	1,400
Minimum deductible for HDHP - Family	2,800	2,800
Maximum out-of-pocket for HDHP - Individual	6,900	7,000
Maximum out-of-pocket for HDHP - Family	13,800	14,000
Excise tax rate for taxable non-medical distribution	20%	20%
