2023 HSA and Excepted Benefit HRA Limits Announced

Starting in 2007, the Tax Relief and Health Care Act of 2006 (TRHCA) requires that the IRS release the upcoming year's new HSA and Excepted Benefit Health Reimbursement Arrangement (EBHRA) limits prior to June 1st. Thus, we now have the 2023 limits as follows:

Annual catch-up contribution limit (age 55 to 65)	1,000	1,000

Maximum out-of-pocket for HDHP - Individual	7,050	7,500
Maximum out-of-pocket for HDHP - Family	14,100	15,000
Excise tax rate for taxable non-medical distribution	20%	20%
